2025 Club Piscine Christmas Giveaway

Rules

1. DURATION OF THE GIVEAWAY

- 1.1. The "Club Piscine Christmas Giveaway" giveaway (hereinafter referred to as "the Giveaway") is organized by Club Piscine (hereinafter referred to as "Club Piscine");
- 1.2. The giveaway begins on December 1, 2025, and ends on December 22, 2025, at 11:59 p.m.;

2. GIVEAWAY DESCRIPTION

- 2.1. The giveaway offers the chance to win six (9) different prizes over a period of twenty-two (22) days through our social media channels (Facebook and Instagram), our newsletter and online orders. The prize and conditions of entry will be announced in three (3) Facebook and Instagram posts. One publication will be published on each Monday: December 1st, December 8 and December 15 at 9 a.m.
- 2.2 **First publication**: Each person who is subscribed to our newsletter or who subscribes between December 1st and December 22, 2025, gets one (1) chance to win a \$500 Club Piscine gift card.
- 2.3 **Second publication**: Every customer who places an order online at clubpiscine.ca between December 8, 2025, and December 22, 2025, has a chance to win a Club Piscine gift card for the value of their order, up to a maximum value of \$1,000. One order equal one entry. Each online order automatically enters the giveaway. The registration is done automatically when the order is confirmed.
- 2.4. **Third post**: Everyone who already follows or follows our Facebook or Instagram page between December 15 and 22 will have a chance to win one (1) of four (4) \$250 gift cards. Two gift cards will be drawn among all Facebook followers and the other two from Instagram followers. Participants must follow one of the two pages.
- 2.5. Comments that are not related to the giveaway publication, negative or disrespectful comments will not be eligible for the giveaway.
- 2.6 There will be a total of two thousand five hundred dollars (\$2,500) to be won in Club Piscine gift cards. There will be six (6) winners and prizes are non-cashable and non-exchangeable.

3. CONDITIONS OF ELIGIBILITY

- 3.1. Participants must reside in Quebec or Ontario.
- 3.2. The participant must be 18 years of age or older.
- 3.3. Club Piscine retailers, their employees, representatives and agents, as well as persons with whom they are domiciled, may not enter the giveaway.
- 3.4. First publication: Participants who enter the draw from among subscribers to our newsletter must be subscribers to our newsletter on the day of the draw, December 23, to be eligible for the giveaway.
- 3.5. Second publication: Participants who enter the draw from online orders must have placed an online order between December 8 and 22, 2025 at clubpiscine.ca and received an order confirmation number to be eligible for the giveaway. It is this order number that confirms automatic participation in the giveaway.
- 3.6. Participants who report and obtain a refund on the purchase of their entire order risk having their participation in this giveaway cancelled, all at the discretion of the Contest Organizer.
- 3.7. Third publication: Participants who enter the draw among subscribers to our Facebook and Instagram pages must be subscribed to our Facebook or Instagram account on the day of the draw, December 23, to be eligible for the giveaway.

4.AWARDING OF PRIZES

- 4.2. The random draw of the five (5) winners among subscribers to our newsletter and social media will take place on December 23, 2025, at 10 a.m. at Club Piscine's head office located at 888, boul. Bois-des-Filion, Quebec.
- 4.3. The random draw of the winner among the online orders will take place on January 9, 2026, at 10 a.m. at Club Piscine's head office located at 888, boul. Bois-des-Filion, Quebec.
- 4.4. The five (5) winners of the draw among our newsletter and social media subscribers will be announced on Facebook Instagram by a representative of Club Piscine's head office on December 23, 2025, at 1 p.m. in the form of a publication.
- 4.5. The winner of the draw among online orders will be contacted by telephone and/or email by a Club Piscine head office representative within ten (10) business days following the draw.

- 4.6. Winners will then be required to confirm their acceptance as an eligible entrant selected according to the instructions provided, all no later than forty-eight hours (48h) after being contacted by a Club Piscine representative. If the selected Eligible Entrant cannot be reached, or if the winner is unable to prove that he/she meets all giveaway conditions, a new draw will be held. Before being declared a winner, the selected Eligible Participant will be required to correctly answer a time-limited mathematical skill-testing question and sign a waiver and release form confirming, among other things:
- That he/she complies with the admission requirements.
- That he/she has read the giveaway rules and complies with them in every respect.
- That he/she accepts the prize was awarded.
- That he/she acknowledges Club Piscine's right to publish his/her name and city without compensation other than the prize.

Club Piscine reserves the right, at its sole discretion, to cancel, terminate, modify or suspend, in whole or in part, this giveaway, in the event that an event and/or situation arises that could alter or influence the administration, security, impartiality and/or conduct of the giveaway as provided in these rules, particularly in the event of a computer problem, subject to the approval of the Régie des alcools, des courses et des jeux, if required;
